#### Project Modification (timetable & budget)

During BestU project, internal and external causes brought some difficulties.

BestU partners implement the project, following the structured Form as described in :

- a. The Application Form (timetables, financial information, budget forecasts etc.)
- b. The Subsidy Contract and
- c. The Partnership Agreement
- d. The Call for Proposals

Changes occurring during BestU lifetime did not affect the above mentioned documents.

Different categories of project changes drive the project to a modification request. It is important to note that approval of project changes should not be considered as an automatic procedure.

Chapter 2.6 in the Project implementation Manual describes the 3 levels of project changes







#### **2 Important Notes**

In all cases, **the Lead Beneficiary must inform the JS** any requests for modification of the project and, according to the proposed changes, the respective JS officer will define the procedure to be followed.

It must be noted that the discounts of the contracts are not subject to modifications and any respective savings shall be returned to the Programme.

Only in exceptional cases and in case of force majeure, these discounts can be re-used and/or re-allocated in the project through a modification approved by the Monitoring Committee.







#### 1<sup>st</sup> Level of Project Modification

#### With Notification of the JS/ Managing Authority

#### Adjustments:

- 1. Administrative Information in the Application form such as changes of contact details, addresses and other data of minor significance.
- Modification of bank accounts
- 3. Adjustment of the Specification/justification of budget cost that does not affect the scope of the project or any information in the Application form.
- 4. Adjustment of starting and ending dates of work packages without affecting the overall end date of the project.
- 5. Adjustment between the respective budget categories and/or work packages for amounts up to 10% of the total budget of the project. The percentage of the requested for reallocation amounts will be calculated compared to the initial Application form as approved with the signature of the Subsidy Contract. This will be applied only in cases where there is no change of the scope of the project.







Changes, regarding 1st Level of Modification shall be integrated in the Application whenever considered necessary by the JS Project Officer, or with the next official version of Application Form, as to be derived by any subsequent modification falling into the levels of the Managing Authority approval or the Monitoring Committee approval.

The JS/MA reserves the right not to approve adjustments in the following cases:

- a. They affect the objectives and expected results of the project (physical activities).
- b. The adjustment of budget is above 10% compared to the initial Application form as approved.







#### 2nd Level of Project Modification

#### Approved by the Managing Authority

- 1. Reallocation between the respective budget categories and/or among work packages for amounts up to 20% of the total budget. The percentage of the requested amounts for reallocation will be calculated compared to the initial Application Form as approved with the signature of the Subsidy Contract. For reallocations between the respective budget categories and/or among work packages for amounts greater than 20% of the total budget, the Managing Authority will, initially, examine the level of significance of the requested reallocation. If the significance is deemed of low importance, the approval is going to be decided by the Managing Authority. If it is deemed of high importance, the request for modification will be proposed by the Managing Authority to the Monitoring Committee to decide on its approval.
- 2. Extension of the date set for closing project implementation activities, if not affecting the achievement of the target set by the n+3 rule.
- 3. Reallocation of resources between beneficiaries from the same Member State, at the same ERDF rate of contribution, which may result in a change equal to or less than 10% of the project budget (ERDF + National Co-financing). Reallocation of fund between beneficiaries may be accepted only if it does not involve an increase in the ERDF contribution of the project.







The 3rd Level of Project Modification cases are approved by the Monitoring Committee and involve;

- 1. Reallocation between the respective budget categories or between actions for amounts greater than 20% of the total budget of the project.
- **2.** Reallocation of resources between beneficiaries from the same Member State, at the same ERDF rate of contribution, which may result in a change greater than 10% of the project budget (ERDF + National Participation).
- 3. Changes to the nature of the project and in particular to the objectives and the expected results. In principle, it is not allowed to change the content of the project, especially the objectives and the expected results.
- 4. Modification to the composition of the partnership
- 5. Budget modifications decided by the Monitoring Committee on the basis of sound financial management of the Programme.
- 6. Reallocation of resources between beneficiaries from different Member States.
- 7. Addition of new activities leading to the increase of the project budget







#### Based on,

- ❖The unanimous agreement of the PMT members which was taken during the 3rd partners' meeting in Bansko on the 20th of September 2018, regarding a request to the JS for the extension of the BEST-U duration
- ❖The official request that the LP, ANATOLIKI S.A., has addressed to the JS, on the 4<sup>th</sup> of February 2019, for the extention of the BEST-U duration
- ❖The notification on behalf of the JS to the LP that a 3-months extension has been adressed to the Managing Authority by the JS and a formal approval is expected,

Please let us now for any modification on the workplan and the budget you might need, having in mind an extension of the project till the 31<sup>st</sup> of December 2019.

The requested changes to the partners' budget should be within the "10% flexibility rule" so as only the approval from the JS to be required and in no case will a necessity for a formal modification of the approved application form arise.

All necessary changes will be communicated in advance to the JS project officer of BEST-U by the LP for approval.
